



## Washington D.C. ~ April 17-April 20, 2020

### Trip Payment Agreement:

We hereby state our intention for the student, \_\_\_\_\_, to participate in the Wakeland High School Choir trip to Washington D.C. from April 17-April 20, 2020.

This document will serve as our commitment to pay the necessary funds for the trip. The above named student will do his/her best to pass all classes so that he/she will be eligible for the trip and will fulfill his/her obligations and responsibilities as a performing member of the WHS choirs.

We understand that the above named student must pass all classes on the 3<sup>rd</sup> quarter grading period report card (which ends on March 27, 2020) in order to be academically eligible for the trip.

We acknowledge that the students must be eligible for, and participate in the UIL Concert and Sight-reading Choir Contest during the spring of 2020 to go on the trip to Washington D.C.

Due to airline deposit requirements / deadlines, a deposit must be paid by Friday, November 1, 2019 in order to secure a place on the trip.

Due to deposit and payment deadlines by the travel companies, late payments may result in the student being dropped from the trip.

### Payment/Refund Agreement:

We acknowledge that a trip deposit of \$175.00 is due by Friday, November 1, 2019 and is totally non-refundable under any circumstances.

We understand that we will not receive this deposit back if the student becomes ineligible, does not participate in the 2020 UIL Concert and Sight-reading Choir Contest for any reason, is dismissed from or leaves the WHS Choir program for any reason, chooses not to participate for any reason, or is unable to make the trip for any reason.

We understand that retention of these funds is necessary in order to meet any cancellation penalties and help defray additional costs to others incurred by my withdrawal from the trip.

Because of travel companies, airlines, entertainment venues and hotels need deposits and payments months before the trip, these payment time lines and non-refundable dates are in effect regardless of the eligibility of the above named student.

### Payment Schedule:

Friday, November 1, 2019	\$175.00	deposit due (non-refundable)
Monday, December, 2, 2019	\$175.00	payment due
Thursday, December 19, 2019	\$ 100.00	payment due
Friday, January 31, 2020	\$175.00	payment due
Friday, February 21, 2020	\$175.00	final payment due

### Refund Schedule:

after Friday, January 31, 2020	50% (less deposit)
after Friday, February 21, 2020	No refund

\*\*\* No refunds will be given after Friday, February 21, 2020\*\*\*

This refund policy is in effect even if the above named student becomes ineligible at the end of the 3<sup>rd</sup> quarter grading period. The 3<sup>rd</sup> quarter grading period ends March 27, 2020.

The 3<sup>rd</sup> quarter grading period report card is very close to the trip, so... students, pass those classes. 😊
